This agreement is made and entered on [22/06/2021] between the Ministry of Education, Science, Culture and Sports of Montenegro; Vocational education center of Montenegro; Chamber of Economy of Montenegro; Educational center "Montenesoft" LLC; "Liming projekt" LLC; Language Centre "OPEN DOORS" LLC; Public institution Mixed secondary school "25th May" in Tuzi, IPC Tehnopolis, ProAct LLC, Science Technology Park Montenegro, Core Consulting LLC, Codepixel LLC, Amplitudo LLC, 2QL4U LLC.

1. Purpose and Background

HISTEK is a project funded by the Programme Interreg IPA CBC Italy-Albania-Montenegro 2014-2020. The project aims at enhancing SMEs' capacities of competitiveness, innovation and internationalization, through the creation of a new national cluster with the goal to join in CBC cluster whose members are SMEs, Training Organizations and Public Institutions, strongly committed to set-up and carry on, with a co-responsible approach, a cross-border innovation community. In order to improve SMEs' competitiveness and innovation, one of the most important leverage is represented by human resources, i.e. companies, especially those ones that have already or intend to establish new branches in CB area, need very highly qualified technicians according to CB common standards, to allow and to favor their mobility in the 3 Countries.


For this reason, with this Agreements Partners would create the national cluster with the goal to join in the CBC cluster, that will work soundly to develop common tools for assessing SMEs' needs in terms of human resources, and to create common standards to be adopted in the education systems for developing young highly qualified technicians. This represents in fact a strategic framework condition for the development of SME's cross-border market.

The National cluster and CBC Cluster will be immediately operative; through a pilot action whose key elements are:

- 1) creation of a CB Assessment Tool Kit to be used by SMEs in recruiting activities of young technicians;
- 2) design of a new join (IT-AL-ME) CB tertiary education course, to be implemented soon after the end of the project, able to train high specialized technicians with advanced high technical preparation, particularly focused on Key Enabling Technologies. In fact, KETs are considered essential for growth and employment, since they provide the basis for innovation in a wide range of industries;
- 3) dedicated toolkits and guidelines for improving the capacity of SMEs to deal with practical learnings inside the company and with mentoring activities.



3. Duration

This Agreement may be modified by mutual consent of authorized officials from all Partners. This Agreement shall become effective upon signature by the authorized officials from all the Partners and will remain in effect until modified or terminated by any one of the partners by mutual consent. In the absence of mutual agreement by the authorized officials from all Partners this Agreement shall end on 02/04/2028. If the contract governing the relations in the CBC cluster terminates this agreement is null and void.

4. Scope of Work

The goals mentioned in article 1 will be accomplished by undertaking the following activities:

- ensuring, with continuity, the educational offer for technicians referred to 5 EQF level in relation to figures who respond to the demand coming from the world of companies in relation to the manufacturing sector;
- supporting the integration between education, training and work systems, with particular reference to the technical-skills emerged within HISTEK project;
- supporting measures for innovation and technology transfer to small and medium-sized enterprises;
- spreading the technical and scientific culture and promote the orientation of young people and their families towards the technical professions;
- establishing transnational relationships between Italy-Albania-Montenegro;
- promoting a worldwide level HISTEK project with its goals, objectives and results.
